

JUNIOR RECREATION / TEEN PROGRAM

2010 INFORMATION AND REGISTRATION

The Junior Recreation Program will be open to residents ages 10-13 (incoming sixth, seventh and eighth graders.) The Teen Program is open to residents age 14 (incoming ninth graders.)

Attention Parents: The Junior Rec. program is geared towards sports (tennis, sailing, kayaking, swimming) and active games, interspersed with various arts and crafts. The Teen program is geared towards team problem solving activities, tennis, and sailing. Children in the Junior Rec. / Teen programs should participate willingly and enthusiastically. **Please make sure your child is interested in this sort of program before signing him/her up.**

The Junior Rec. / Teen Programs will provide **tennis** instruction, **swimming** instruction (if requested), **sailing, kayaking and waterskiing** instruction. All activities are weather permitting. The sailing program will be run by experienced sailors/counselors utilizing our fleet of Hunter sailboats. Waterskiing instruction will be conducted by certified instructors. **Children will need a life jacket, tennis racket and sneakers for camp.**

Registration will take place at **Lloyd Harbor School on March 6, beginning at 9 a.m.** *The fee and two copies of the most recent health examination (dated not earlier than 2009) must accompany the registration form.* All updated health examination forms MUST be received by April 20, 2010. Please be sure that a list of updated immunizations and the doctor's signature are on the health examination form. To register after March 6 **or if you cannot register your child on March 6 (due to illness, death in the family or travel),** please call the camp information number at 516-501-6950 or e-mail the director at JbartonLHVP@aol.com .

Camp will run from 10 AM to 3 PM, Monday through Friday (Teen Camp hours are from 1 PM to 5 PM). THERE WILL BE NO CAMP ON INCLEMENT DAYS.

Junior Recreation is a four-week program. Teen Camp is a two-week program. The weeks are consecutive, non-transferable, non-refundable and cannot be broken up. *Please circle your choice below:*
