- Fee and 2 copies of most recent medical form must accompany registration form. All updated medical forms MUST be received at Village Hall by April 20, 2009.
- Registration fee is not refundable after child has been enrolled. Weeks enrolled are non-transferable.
- Make checks payable to *Village of Lloyd Harbor*. Fee must accompany application.
- Registration for additional weeks after initial registration (maximum 4 weeks) has taken place will be billed at \$225 per week.
- Children residing in Lloyd Harbor year round will be given first priority.
- Children must be 5 years by December 1, 2010
